7. Entries

7.1 Entry procedure



- Entries must be submitted via: www.rallyscore.net . This is a two part process, the actual entry form submission and payment.
- Entries must be paid in full, including insurance for the event (if required), Membership is necessary unless a current ANICC club member.
- An entry will only be accepted when accompanied by the total entry fee.
TBA can be used but note only one amendment per entry can be made!!
- Payment of entries is only via stripe as linked to www.rallyscore.net

8. Entry Selection Criteria

Places will be allocated to **Crews** in the following order:

1. The first three registered per class in the McGrady Insurance Motorsport UK ANICC Northern Ireland Stage Rally Championship at the final closing date for entries.
2. MADMC reserve the right to select 20 of 120 competitors entered at their discretion.
3. Any current MADMC member prior to publication of these regulations
4. Registered Micra Challenge Competitors must be in a Nissan Micra car.
5. In Order of receipt of a fully completed paid entry.

ALL of the above is based on receipt of fully* completed entry forms and payment.

If more than 100 entries are received a reserve list of up to 20 potential competitors may be assembled.

*Fully completed includes Results in Results Section. In the event of NO Results listed in the entry form, you have waived your right to a Reseed.

A Reserve List:

Your name may appear on a reserve list if you do not meet the above criteria. In the event of your name being placed on a reserve list. We advise that you, as competitors:

Get the car ready, get Crew ready i.e. Licence/suit etc ...BE READY TO GO!!

The Reserve lists only come into operation in the 48/24hrs prior to the event, when the main field competitors can't compete.

Please be patient as we the organiser's have a permit to start 100 cars and 100 cars we aim to START! Reserve list Crews will be updated regularly....remember the above **BE READY!**



On submission of your entry you will receive an acknowledgement email from rallyscore. You will NOT receive any written correspondence in relation to the event from the club. All future correspondence will be posted on the MADMC Website/facebook/Sportivity app.

To ensure individual contact is possible with Driver/Navigator, please ensure both individual email addresses and contact mobile numbers are correct.

8.1 Additional Information RE: Accepted Entries

- The number of competitors shall be limited to 100 plus 20 reserves and the minimum will be 80. Should the minimum figure not be reached, the Organisers reserve the right to cancel the meeting, amalgamate classes or reduce the rewards list as deemed appropriate.
- Competitors are advised that when completing the form online please do this as fully as possible, only ONE amendment to the form is allowed I.E. driver/navigator details, car or class until seeding of entries.
NB. When seeding is completed, the named driver CANNOT be changed.
- The starting order will be at the organisers' discretion, but to assist seeding, entrants must note their previous results on the Entry Form. Failure to disclose previous results may lead to incorrect seeding, which may not be rectified.
- Any indemnity and/or declaration as prescribed below which is signed by a person who has not reached their 18th birthday shall be countersigned by that person's parent or guardian, whose full name and address shall be given. Any entry may be made by electronic means of communication must be made by the parent or guardian, whose full name and address must be given (2024 Motorsport UK GR H32 and D12.3.8).
- Any person under the age of 18 signing on as specified in 2024 Motorsport UK GR D13.1 (where the parent is not present) must be accompanied by a Guardian who must produce a written and signed authorisation from the Parent to act as Guardian (2024 Motorsport UK GR D13.1.1).
- Organisers reserve the right to accept or refuse entries at their discretion. All entries will be acknowledged but will not be accepted until FULL payment is made.
- In the event an entry being accepted after the closing date, the competitor details will not appear on the entry list. These entries will be reseeded on the morning of the event.

8.2 Entry fee refunds

Any due entry fee refunds will be **refunded AFTER** the event/event date via stripe. Stripe refunds take about 7-10 working days to reappear in the payees account.

- Entry fees will be refunded less:
MADMC an administrative charge of £50.00* may apply from 27 April to 12 May 2024. After this date a refund of entry fees will be at the organiser's discretion, except in the circumstances referred to in Art 4.6.2. **Reserve entries that are not offered a start will receive a full refund*** subject to 2024 Motorsport UK GR H30.1.3(c).

*Further possible charges beyond MADMC control includes Rallyscore and Stripe.

8.4 Eligible cars for the event will be as follows:

The championship is divided into Eleven Classes as per the ANICC McGrady NI Rally Championship Regulations 2024, please read the class notes below prior to class entry.

1	Historic rally cars registered before 31/12/90 (Motorsport UK Cat 1, 2, 3, 4a and 4b. Ref: R49-2024 Motorsport UK Blue book.) and historic rally cars complying with FIA Appendix K. (Ref: R49.2 of 2024 Motorsport UK Blue Book)
2A	FIA 2WD: FIA Rally4, FIA R2. FIA Group N cars up to and including 2000cc (see Article 5.13 for Group N definition).
2B	FIA 2WD: FIA Rally5, FIA R1. FIA Group N cars up to and including 1600cc (see Article 5.13 for Group N definition).
3	Clubman 2WD up to 1450cc: Cars up to and including 1450cc and cars from 1451cc up to and including 1650cc; having not more than 2 valves per cylinder. Two-Wheel Drive Cars Only
4	Clubman 2WD up to 1650cc: Cars from 1451cc up to and including 1650cc, having more than 2 valves per cylinder. Two-Wheel drive cars only.
5	Clubman 2WD up to 2100cc (2 Valve): Cars from 1651cc up to and including 2100cc, having not more than 2 valves per cylinder. Two-Wheel drive cars only.
6	Clubman 2WD up to 2100cc (multivalve): Cars from 1651cc up to and including 2100cc, having more than 2 valves per cylinder. Two-Wheel drive cars only.
7	Clubman 2WD over 2100cc: Cars over 2100cc. Two-Wheel drive only.
8	Clubman 4WD: Any 4wd cars not classified in class 9 or 10, without a sequential gearbox (including previously FIA Homologated GpN 4WD cars) 4WD Historic Rally Cars homologated before 31/12/90 (Motorsport UK Cat 1, 2, 3, 4a and 4b. Ref: R49 2024 Motorsport UK Blue Book). 4WD Historic Rally Cars complying with FIA Appendix K. (Ref: R49.2 of 2024 Motorsport UK Blue Book) (See Article 5.14).
9	FIA 4WD National: FIA Rally3. FIA Homologated GpA 4wd cars... and any cars previously homologated as such, providing these run as per their FIA Homologated papers. FIA Homologated Super 2000 cars...and any cars previously homologated as such, providing these run as per their FIA homologation papers. FIA Homologated R4 Cars,... and any cars previously homologated as such, providing these run as per their FIA Homologation papers.
10	FIA 4WD International: FIA Homologated Rally2 (R5) cars providing these are run as per their FIA Homologation Papers and FIA Homologated WRC cars and cars previously homologated as such providing these are run as per their FIA Homologation Papers. Including any derivative of FIA Rally2 (R5) car converted to RHD whose conversion has been supported with photographic evidence and original LHD homologation papers for that vehicle. Championship organisers reserve the right to reclassify a car to Class 11 if pre-event scrutineering reveals changes to the vehicle specification that are considered to improve the vehicle's performance.



11	Open Class: Motorsport UK GT Cars, Rally 2+ (R5+) (being Group Rally 2 (R5) cars modified beyond their homologated specification). All Metro 6R4 and any derivative there from. Any other 4wd car not classified in Class 9 or 10 with a sequential gearbox. Any other car not classified in Classes 1-10.

8.5 Class Notes:

1. Vehicle Regulations for Class 1 (Appendix K) (Note: ALL competitors take note of Article 5.16). In order to run under Appendix K, Historic Rally Cars must have been issued with a valid FIA Historic Technical Passport (HTP), be in compliance with this document and the current FIA Appendix K at all times. Vehicles are exempt from R 46.1.3.
2. Vehicle Regulations for Classes 2 and 8. [NB Class 2 and Class 8 no longer caters for “standard production cars”. The relevant FIA Group N Homologation Papers must be produced at each event and cars must comply fully with Group N Regulations.] Cars eligible for Classes 2 are those, which are, or have at any time been, homologated in Group N as defined in FIA Appendix J.5.13.2. The standard specification of any model shall be determined by FIA Homologation papers in the case of current and former Group N cars. In all cases the degree of modification from standard shall be as provided for under FIA regulations for Group N. The onus of proving eligibility for Classes 2 & 8 rests solely with the competitor who should ensure that homologation papers are available at events. Regulation in note 4 applies.
3. Any Class 3 competitor not using the single make tyre will be moved into Class 4.
4. Except where covered by Championship regulation, vehicles with forced induction (except diesel engines) and rotary engines will have their engine capacity increased by 70% to establish their class (2024 Motorsport UK GR J5.4.1).

9. Road Risk Insurance Cover for Saturday 18th May 2024

Road Risk Insurance details are currently being finalised, further details will be available ASAP

Application for insurance cover must be made at time of entering the rally; a later application is NOT possible.

This cover will provide Competitors who need to use the scheme with Third Party Cover necessary to meet Road Traffic Act (RTA) Insurance Scheme on the Road sections of the Event only. The basic rate is **£TBA** for the day. (before any loadings i.e. if unable to comply) (This cover is **NOT** included in the entry fee).

Automatic acceptance will be given to all competitors meeting a criteria, similar to:

- Aged 19 years or over
- Has held Full licence for a minimum of 6 months.
- Has no more than 6 points on their licence.
- Has had no more than 1 fault claim in the last 3 years.
- The vehicle must hold a valid MOT certificate, current Road Insurance, and Road Tax unless except from doing so.
 - All competitors must be a named driver on the road insurance.
 - Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

TBA Insurance cover is effective from the start ramp to the finish ramp/retirement (whichever comes first) with your own insurance becoming effective.



If you as a driver cannot comply with the above criteria please contact TBA directly on: xxxx xxx xxxx ASAP.

10. Minimum Acceptable Licences

Drivers: RS Interclub Stage Rally

Navigators: Interclub, RS National, Race National, RS Rally National Navigator and any International Licence.

NB: Competition Licence's CANNOT be applied for via the club, the onus is with the Driver/Navigator.

10.1 The non - production of competition licence:

If a competitor insists that they have the appropriate licence to compete in the event but cannot produce a licence, the Motorsport UK Steward may check the Motorsport UK system to validate that a claimed licence exists, remains valid and has not been suspended. If the Motorsport UK Steward is satisfied that a valid and appropriate licence exists, the competitor must complete a Non Production of Licence Form, which must be countersigned by the Motorsport UK Steward, so that it can be accepted by the Secretary of the Meeting. This will result in a non-refundable fine. No payments will be taken at the event and they must be paid to Motorsport UK directly by the competitor within the specified timeframes.

11. Advertising and Identification

Competitors must make available to the Organizers of the event specific areas (2024 Motorsport UK GR H28.1.1 and H28.1.2) on the vehicle as shown on the diagrams in Appendix: 2. The organisers will supply all event decals including door plates, door headers, and competitor numbers, front and rear plates and hi-visibility competition numbers for display as per McGrady Insurance NI Stage Rally SR 2024.

12.1 Noise Test, Scrutineering of Vehicle & Driver/Navigator's safety equipment

Rally cars must be presented in same condition as they intend to compete.

Ensure all Previous Competition Numbers are removed from the car prior to Scrutiny.

A valid MOT/NCT Test Certificate, proof of Tax, must available for production at Scrutineering for any car required by UK law to have one.

A Noise Test, Scrutineering, Inspection of Driver & Co-Driver's Rally wear, Helmets/FHRs of ALL cars will take place at scrutiny, thereafter and random inspections throughout the day.

12.2 Special requirements

Competitors wishing to carry on board camera(s) during the event must declare to the Chief Scrutineer on arrival at scrutineering and complete the necessary documentation (2024 Motorsport UK GR R48.10.10). Cars must be presented at scrutineering with the Dcamera(s) fitted. Cameras that are affixed to the outside of the vehicle by temporary fixing devices including, but not limited to, suction devices, must also be attached to a permanent bracket or non-removable bodywork by means of a restraining strap. Cameras



that extend outside the extent of the door mirrors when viewed from the front of the vehicle are prohibited.

The organisers may request the removal of video footage from on board cameras deemed to be offensive or of a sensitive nature should it be posted on the internet or social media websites. Any competitor who does not comply with this request may be reported to Motorsport UK for further action.

12.3 All cars must carry: OK/SOS board, Warning Triangle, Spill Kit & Sanitizer.

Failure to attend scrutineering & Paper documentation within the time specified = Start Refused

12.4 Competitor Documentation Production & Insurance Sign-on.

Following Scrutiny, competitor(s) are asked to report to paperwork documentation within 20 minuteswhere:

1. Your scrutiny sheet is collected.
2. Licences and memberships – will be inspected.
3. Competitor Sign-on sheets: Driver & Navigator, must sign
4. Competitor Emergency Contact Details checked.
5. Insurance declaration MUST be signed by the Driver.

Many Thanks, your co-operation in attending, it is greatly appreciated.

13. Service Area

Ronan Valley Business Park, Ballyronan Road, Magherafelt. BT45 6EW.

Reminders within the service area:

- Drivers: Please drive responsibly within the service area. **i.e. 5-10mph.** Excessive speed will be penalised as per SR 17.23.
- Crews and Service Crews **MUST** obey all Officials & Marshals on the event at ALL times. Failure to do so will be penalised as per SR 18.28.
- All crews **MUST** provide and use a ground sheet.
- Refuelling is **ONLY** permitted once - at the Main Lunchtime Service
- The service van must carry a Fire Extinguisher.
- Collect the refuse bag issued on the way into service, & dispose in the skip provided.

14. Recce Procedure

Competitors may make **ONE** choice of day for a low speed (30 mph) reconnaissance at time of application via www.rallyscore.com during the following times:

Collection of Road Books/Paperwork will be 9:00 – 11:00 ONLY each day

Sun 12th May 2024: 09:30 - 16:00hrs (Recce Documentation Collection - TBA)

Fri 17th May 2024: 09:30 - 16:00hrs (Recce Documentation Collection - TBA)

Only **1 A5 size Road Book/per crew** will be issued, collectable on your chosen date.

From publication of these regulations any competitor found on the stages outside of Recce date will be excluded, **NO EXCEPTIONS!!**

To enforce this regulation all the people named in these SR's have been appointed judges of fact.

During the reconnaissance period the PSNI and the organisers will arrange speed checks and general patrols of the special stages, and competitors driving or being driven at an excess speed or in a manner which in the opinion of the organisers causes or could cause danger or inconvenience to other road users or local residents or could bring the sport into disrepute will be penalised as per SR 17.23.



Further details for the reconnaissance will be available on the MADMC Website / Sportivity app.

Reconnaissance cars must conform to the following criteria:

- Only standard cars may be used.
- Competitors will be permitted 3 practice runs over the stages ~ Road books, the 3 timed runs recorded.
- The engine must be a series production engine (complying with the Group N regulations).
- No advertising may be carried on the car.
- The organisers have the power not to allow the use of any particular car.
- A competitor who practices, reconnoitres or otherwise examines a Special Stage or uses any other person(s) to do so on his/her behalf, outside of the dates and times stated above, will be excluded from the competition without refund and reported to Motorsport UK – THIS WILL BE STRICTLY ENFORCED.

Please do not risk the future of closed road rallying by Recceing inconsiderately, remember these roads are open to the public and respect other road users and the local residents who are accommodating your sport.

In all circumstances, competitors are advised that the organisers accept no liability or responsibility in the use of the subjective route notes.

16. Timing/Timecards

For all sections of the event timing is set to BBC/BT Timing, and will be timed using Digital clocks to 1/10th of a second from standing start to flying finish on Roads closed to the Public. (Motorsport UK GR R31.1 – R31.2.1) as per Motorsport UK Yearbook 2024)

The starting for special stages will be given by means of “Start lights” which will work as follows:

30 seconds	RED light will be displayed
15 Seconds	RED and AMBER lights will be displayed
10 Seconds	RED light will go out



5 Seconds	AMBER countdown 5,4,3,2,1
START TIME	GREEN light goes ON

The finish time will be displayed on screen in mins, seconds and 10ths of a second with your car number. It is up to the navigator to record his/her time on their timecard. The definitive checks will be the stored times in the clock and the marshals check sheet.

All controls will open 15 minutes before the Due Time of the first car and close 15 minutes after the Due Time of the last competitor still running (2024 Motorsport UK GR R30.1), having taken into account any delays.

In the event of unforeseen circumstances arising affecting the Road Closing Order, the organisers are seeking approval from Motorsport UK to use 30 second starts.

16.1 Missing a control or stage

Crews are reminded that it is their responsibility to ensure their car is SAFE to compete. This includes after an incident, continuing to compete in a vehicle unfit to drive on the public highway will be considered bringing the sport into disrepute.

Crews missing a Control or Special Stage will be penalised in accordance with SR 17.4 and SR 17.10.

16.2 Red Flag Procedure

Competitors are reminded to read and understand the Red Flag Procedure as described in 2024 Motorsport UK GR R25.6.4.

“On passing a Red Flag displayed by a marshal wearing a marshals’ tabard, the driver MUST immediately and significantly reduce speed as well as being prepared to stop at any time; at no time must they overtake any safety vehicle they encounter on the special stage route. The driver must then follow the instructions of any marshals and/or stage safety personnel and maintain this reduced speed until leaving the special stage.

Failure to comply with this rule will incur a penalty at the discretion of the Clerk of the Course.

17. Penalties

Each special stage will have a Bogey Time set at 75mph for sealed surfaces which will be indicated on the Time Cards

Competitors will receive penalties as follows:

- 17.1 Achieving a time which is less than the minimum time stated on the time card- MINIMUM TIME FOR STAGE.
- 17.2 Achieving a time which is greater than the maximum time stated on the timecard - MAXIMUM TIME FOR STAGE
- 17.3 Achieving a time which is between 1 and 2 above – ACTUAL TIME IN MINUTES and SECONDS (and tenths of a second)
- 17.4 Failure to attempt a special stage – Exclusion.
- 17.5 Failure to follow specified stage route – MAXIMUM TIME FOR STAGE.
- 17.6 Failure to start a special stage when instructed – 10 MINUTES



- 17.7 Any competitor/person acting on behalf of a competitor found on any stage, after the publication of regulations, until the finish of the event will be excluded. The person or persons will be reported to the Motorsport UK/MI for possible further penalties.
- 17.8 Reporting at any Control after due time – 10 SECONDS PER MINUTE.
- 17.9 Reporting at any Control before due time – 1 MINUTE PER MINUTE
- 17.10 Not reporting at a Control – EXCLUSION.
- 17.11 Wrong approach or departure at a Control – 10 MINUTES.
- 17.12 Servicing outside designated service area(s) – EXCLUSION.
- 17.13 Reporting at a Control 15 or more minutes after due time – EXCLUSION.
- 17.14 Absence of a recorded time on a time card – EXCLUSION.
- 17.16 Failure to produce or surrender any Time Cards on request – EXCLUSION.
- 17.17 Misconduct by any competitor/service crew – EXCLUSION.
- 17.18 Making a false start on a stage – ONE MINUTE.
- 17.19 Breach of statutory driving regulations crew/service vehicle: EXCLUSION
- 17.20 Receiving assistance contrary to R38 – EXCLUSION
- 17.21 Failure to attend drivers briefing – a random selection of drivers and co-drivers may take place – 5 MINUTES
- 17.22 Not complying with a requirement of the road book – 10 MINUTES
- 17.23 Excessive speed or conduct likely to bring motor sport into disrepute – 1st Offence – 10 MINUTES – 2nd Offence EXCLUSION.
- 17.24 Excessive noise in breach of MOTORSPORT UK limits – EXCLUSION
- 17.25 Refuelling a competing vehicle in breach of the event regulations – EXCLUSION
- 17.26 A competing vehicle does not comply with Technical Eligibility – EXCLUSION
- 17.27 Breach of Regulations 40.1.3 – EXCLUSION
- 17.28 Failure to follow the instructions of an Official or Marshal – 5 MINUTES

Competitors will start with zero time penalties. The results will be established by adding the times taken during the special stages and the time penalties incurred on the road sections together with all other penalties expressed in time. The competitor with the lowest total will be the winner and so on. (2024 Motorsport UK GR R40.1.1).

If there is a tie, the competitor who accomplished the best time for the first special stage will be declared the winner. If this is not sufficient to be able to decide between the tied competitors, the times of the second, third, fourth etc. special stages will be taken into consideration. (2024 Motorsport UK GR R40.1.2).

18. Judges of Fact

The organisers will appoint Judges of Fact in accordance with 2024 Motorsport UK GR G10.1.

All start officials on all special stages are appointed Judges of Fact for False Starts 2024 Motorsport UK GR R24.7.3, they will be named in the Final Instructions and/or event noticeboard.

The following named Officials are appointed as Judges of Fact:

Gillian Magee who will Judge in respect of Vehicle Eligibility 2024 Motorsport UK GR G10.2.1. Their report may result in the imposition of a penalty as per SR 17.26.



Liam Shaw who will Judge in respect of sound, 2024 Motorsport UK GR G10.2.2 and 2024 Motorsport UK GR R24.7.8. Their report may result in the imposition of a penalty as per SR 17.24

Michael Doyle who will Judge in respect of Unauthorised servicing, 2024 Motorsport UK GR R24.7.6. Their report may result in the imposition of a penalty as per SR 17.20

Further possible action can be taken if deemed appropriate through reporting these facts to the MSUK Steward or Motorsport UK.

19. Driving Standards Observers

The organisers may appoint Driving Standards Observers in accordance with 2024 Motorsport UK GR G11.1 to G11.2 and 2024 Motorsport UK GR R24.8.

These Driving Standard Observers will be named in the Final Instructions and/or event noticeboard which will apply to both the Recce days and on the day of the rally.

2024 Motorsport UK GR R24.8.1 - Judges and/or DSOs will be appointed to report on sound levels. Excessive sound will include instantaneous occurrence of noise such as that produced by backfiring caused by anti-lag systems. The penalty for this is as per SR 17.23

2024 Motorsport UK GR R24.8.2 & 2024 Motorsport UK GR R24.8.3 - Any Competitor driving at an excessive speed, recklessly, or in a manner likely to bring Motor Sport into disrepute, or convicted of any driving offence committed during the event. The penalty for this is as per SR 17.23

Further possible action can be taken if deemed appropriate through reporting these observations to the MSUK Steward or Motorsport UK.

19.1 Traffic Laws

Throughout the entire event, the crews must observe the traffic laws of Northern Ireland with particular reference to erratic driving prior to entering a special stage (e.g. tyre warming/scrubbing). The PSNI will strictly enforce this regulation, which may go as far as prosecution.

19.2 Cancelled Stages

Should any special stage be cancelled during the event, or deleted from the results after the event, only the stage penalties will be deleted. Unless an official bulletin has been issued to the contrary, the cancelled stage must be traversed within the stage maximum time, and will in every other respect be treated as a road section. An alternative road book will be provided which will direct you to the next time control.

20. Damage Declaration

Competitors will be required to complete a declaration that they have/have not been involved in any incident resulting in damage to private property or injury to persons or animals or alternatively giving details of any such incident where damage or injury has occurred (2024 Motorsport UK GR R40.1.3). Information given will not incur a penalty, but failure to disclose details of any such incident, or failure to hand in a duly completed form will be penalised in accordance SR 17.27 and may be reported to Motorsport UK for further disciplinary action.



This declaration must left in the in box provided at the finish ramp. If a competitor fails to reach the finish ramp the declaration must be completed and returned to the Rally Office or to the Secretary within 72 hours of the finish of the event. Failure to return the form may be penalised by a fine of up to £100. (2024 Motorsport UK GR R40.1.4).

22. Protests and Appeals

Protests and appeals are in accordance with 2024 Motorsport UK GRs.

- Provisional results will be published as soon as possible after the event finish.
- Competitors shall ensure that they and their cars are available for inspection should a protest be submitted in accordance with 2024 Motorsport UK GR C5.2.2. If the protested vehicle is not available for inspection the competitor may be penalised in accordance with 2024 Motorsport UK GR C3.2.

23. Safety Trackers

The rally will operate a mandatory GPS safety tracking system that will enable the speed and position of each competing vehicle to be monitored and logged. Before the start, all cars will be fitted with a tracking device that will remain active throughout the event. This must be retained in the car until the finish where it will be removed by the system providers. If a competitor retires during the event, the device must be returned with the damage declaration form. Failure to return the equipment will result in the driver being invoiced for its replacement.

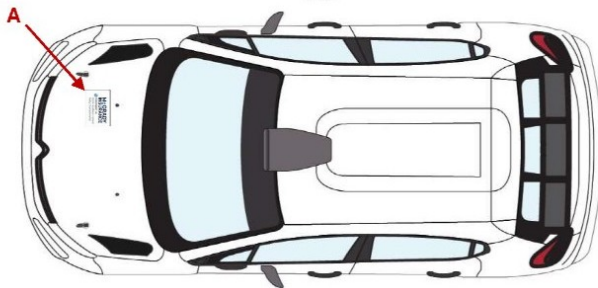
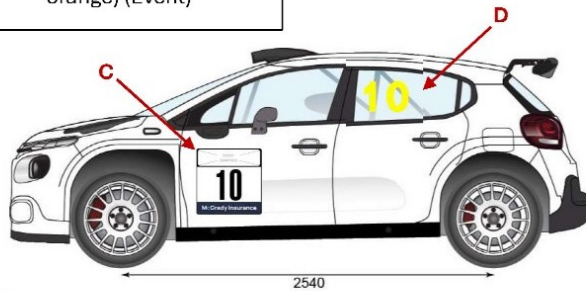
